

Respawn® 2025 National Sweepstakes

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. A VALID EMAIL ADDRESS IS REQUIRED.

1. ELIGIBILITY: The Respawn® 2025 National Sweepstakes (the "Sweepstakes") is offered only to legal United States residents residing in the 50 United States and the District of Columbia, who are 18 years of age or older at the time of entry. Void where prohibited or restricted by law. Employees, officers and directors, of Mars Wrigley Confectionery US, LLC ("Sponsor"), TPG Rewards, Inc. ("Administrator"), their respective owners, parents, subsidiaries and affiliates, advertising and promotion agencies, and any companies involved in the implementation and execution of the Sweepstakes (collectively, the "Sweepstakes Entities") and their immediate family members (spouses, siblings, parents, and children, including foster and step-relations, and their respective spouses) and household members (whether or not related) are not eligible. 2. SWEEPSTAKES PERIOD: Sweepstakes starts on or about 12:00:00 a.m. Eastern Time ("ET") on October 29, 2025 and ends at 11:59:59 p.m. ET on February 28, 2026 ("Sweepstakes Period"). At the conclusion of the Sweepstakes Period, winners will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period. The Sponsor's and Administrator's decisions regarding eligibility, drawing results, and prize awards are final and binding.

3. HOW TO ENTER:

Scan the QR code found on promotional signage in a participating retail store to be directed to the website or go directly to <https://sweepstakes.respawnbyrazer.com/national-2025> (the "Website") during the Sweepstakes Period and follow the on-screen instructions to complete the entry form with the information requested then submit your entry. You will earn one (1) entry into the Sweepstakes after submitting the entry form. All requested information on the entry form at the Website must be completed to enter and to be eligible to win. Incomplete entries will be disqualified. Proof of entering information at the Website is not considered proof of delivery to or receipt by Sponsor of such entry. **There is a limit of one (1) entry per person per day. For purposes of these Official Rules, a 'day' is defined as any twenty-four (24) hour period during the Sweepstakes Period beginning at 12:00 a.m. ET and ending twenty-four (24) hours later at 11:59 p.m. ET.**

All entries become the property of Sponsor and will not be acknowledged or returned. The clock on Administrator's server shall be the official time keeping device for this Sweepstakes. In the event of a dispute about entries submitted by multiple individuals using the same email account, the entry will be deemed to have been submitted by the authorized account holder of the email account used to enter the Sweepstakes at the actual time of entry, as long as such person is otherwise eligible to participate in

accordance with these Official Rules. The authorized account holder is defined as the natural person who is assigned an email address by an Internet access provider, online service provider or other organization that is responsible for assigning email addresses or the domain associated with the submitted email address.
